SICCO (pronounced Sick-O) stands for Spring in Columbiana County Ohio. This ride began in 1995 and is a favorite for area cyclists to welcome in spring. The route is a flat to rolling 35 mile loop through small towns and beautiful countryside including the Little Beaer Creek Greenway Trail. There is a snack stop at the rail station in historic downtown Lisbon. At the end of the 35 mile loop, you get a delicious Pizza Hut lunch. After refueling, try the optional rolling to hilly 28 mile loop for a total of 63 miles.

SICCO begins at Firestone Park (347 E. Park Ave., Columbiana, OH 44408). Registration opens at 8:00am and closes at 10:00am. First riders out at 8:00am. SAG support ends at 3:00pm.
